#### 64.0. GREEN PROMISE

##### 64.1. AVAILABILITY

Available only to customers taking service from Entergy Arkansas, LLC ("EAL" or the "Company") who enter into a Green Promise Agreement (Policy Schedule No. 13.23) Option 1 or Option 2, as applicable, with the Company and who are served under one of the following rate schedules:

1. Residential Service Rate Schedules RS, RT, and REMT
2. Small General Service Rate Schedules SGS, GFS, MP, AP, SMWHR, and CGS
3. Large General Service Rate Schedules LGS, GST, LPS, and PST

This Green Promise schedule is not available to customer accounts taking service under Net-Metering Service (N-M), Small Cogeneration Rider (SCR), Large Cogeneration Rider (LCR), or Solar Energy Purchase Option (SEPO).

The total amount of capacity currently designated to both Residential and Non-residential customers under this offering is listed in Attachment B to this Rate Schedule. Up to 1 MW of the initial designated capacity is reserved for Residential, including Low Income Residential, customers. Green Promise is available to eligible Residential and Low Income Residential customer accounts on a first-come, first-serve basis in the order that completed Green Promise Agreements are received and approved.

The Green Promise capacity reserved for Non-residential customer accounts will be apportioned to each Non-residential customer who submitted a Letter of Intent ("LOI") in advance of May 26, 2022. If a Non-residential customer's requested subscription is limited due to capacity availability, the Non-residential customer's subscription will be fulfilled on a proportionate basis.

After the cut-off date prescribed above, EAL will maintain a waitlist and will fulfill capacity on a first-come, first-served basis from that waitlist. As additional Green Promise Designated Resources are added, participating LOI customers will have their existing subscriptions fulfilled before any remaining capacity is apportioned to customers on the waitlist.

The Designated Capacity and Green Promise Designated Resources (defined below) are listed on Attachment B. As renewable resources are available to be added and/or substituted hereunder, the Company will update the Designated Capacity and Green Promise Designated Resources by filing a new Attachment B with the Commission for approval.

#### 64.2. DEFINITIONS

Capacity of Resources: total capacity expressed in kW associated with EAL's Green Promise Designated Resource(s).

Green Promise Designated Resource(s): the renewable resource(s) designated by the Company to supply renewable energy for Green Promise as noted on Attachment B.

Designated Capacity: amount of capacity (alternating current or "AC") in total of the Designated Resources offered to customers under Green Promise.

Low-Income Residential customers: customers who meet applicable eligibility requirements to qualify for the federal Low Income Home Energy Assistance Program (LIHEAP) in place at the time the customer is enrolled in Green Promise. Customer identification will be determined by account holder name shown on the monthly residential electric bill. Customer must self-certify; the Company may, in its discretion, request proof of eligibility. If a customer has misrepresented his or her eligibility during the self-certification process, the Company may, in its discretion, permanently exclude the customer from participating in Green Promise.

Monthly Resource kWh Output: Total amount of energy (kWh) generated each calendar month by EAL's Green Promise Designated Resource(s). Application for billing purposes will be on a two-month lag.

Green Promise Subscription kW: The total amount of capacity expressed in kW contracted by a customer as described in 64.3.

Green Promise Energy: The monthly energy associated with the customer's contracted Green Promise Subscription kW. [(Customer's Green Promise Subscription kW / Capacity of Resources) x Monthly Resource kWh Output].

#### 64.3. APPLICABILITY

At the time of enrollment, Green Promise customers will elect either Green Promise Option 1 or Green Promise Option 2 for each account.

Green Promise customers may elect to subscribe accounts to a minimum of 0.5 kW of available capacity. Residential customers may elect additional capacity in 0.1 kW increments, and Non-residential customers may elect additional capacity in 0.5 kW increments. The renewable energy associated with the subscription capacity (expressed in kW) shall not exceed 90 percent of the Green Promise customer account's most recent annual billed kWh usage associated with service under the Rate Schedules listed in 64.1.

EAL may evaluate a customer's subscription on an annual basis to determine if the subscription for a customer's account results in an amount of Green Promise Energy that is greater than 90 percent of the customer's billed kWh usage over the most recent twelve-month period for that account. If the Company determines that the subscription results in an amount of Green Promise Energy that exceeds 90 percent of a customer's most recent annual billed kWh usage for that account, the Company may modify the subscription capacity for the account to align with 90 percent of the customer's most recent billed kWh usage associated with service under the Rate Schedules listed in 64.1.

#### 64.4. MONTHLY BILLING

In no month will a customer's monthly bill be less than the otherwise applicable minimum. In the event that the customer's bill would result in the otherwise applicable minimum, any credit amount not applied in the current billing month will be carried forward to the following billing month.

##### 64.4.1 Green Promise Option 1:

- A. In addition to the monthly billing amount under applicable rate and rider schedules, customer's bill will include an amount equal to:

Monthly Subscription Charge + Monthly Subscription Credit

where

Monthly Subscription Charge = Green Promise Subscription kW x Green Promise Option 1 Subscription Charge as defined in Attachment A

Monthly Subscription Credit = Green Promise Energy x Green Promise Subscription Credit as defined in Attachment A

- B. For qualifying Low Income Residential customers, the Monthly Subscription Charge will not exceed the Monthly Subscription Credit. In any month where the Monthly Subscription Charge exceeds the Monthly Subscription Credit, the Monthly Subscription Credit will be re-set to equal the Monthly Subscription Charge.

#### 64.4.2. Green Promise Option 2:

In addition to the monthly billing amount under applicable rate and rider schedules, customer's bill will include an amount equal to:

Monthly Subscription Charge + Monthly Subscription Credit

where

Monthly Subscription Charge = Green Promise Subscription kW x Green Promise Option 2 Subscription Charge as defined in Attachment A

Monthly Subscription Credit = Green Promise Energy x Green Promise Subscription Credit as defined in Attachment A

#### 64.5. CONTRACT PERIOD

If a customer discontinues service with EAL, the Agreement under Green Promise will be terminated except: if 1) the customer is relocating within the EAL service area, and 2) initiates service at a new location at the time of discontinuing the original service, and 3) takes service at the new location under the same rate schedule as the original service. If these three provisions are met, the customer may opt to transfer customer's Green Promise Agreement to the new account for service. EAL may, at its option, petition to revise or withdraw the Green Promise Tariff after the effective date hereof. Further, EAL intends to re-evaluate the terms of the Green Promise Tariff five years from the initial effective date hereof. Notwithstanding, any account which is currently enrolled in Green Promise as of the re-evaluation will be permitted to continue on the original terms of the Green Promise offering through the end of the initial term of that account's Agreement. Thereafter, customer accounts taking new service or service beyond the initial term of their original contract under the Green Promise tariff will be subject to the terms of the revised Green Promise tariff.

##### 64.5.1. Green Promise Option 1

The initial term of the Agreement under Green Promise shall be for a one-year period and shall be extended automatically for successive periods of one year each until terminated by written notice given by one party to the other not more than six months nor less than two months prior to the expiration of the original term or any anniversary thereof.

When a customer elects a subscription amount, the Green Promise subscription capacity must remain in place for a minimum of twelve months. After twelve months, the customer may elect to decrease the customer's subscription, or if subscription capacity is available subject to the waitlist, increase the customer's subscription. Any such change is subject to a modified Agreement, and the new election must remain in place for a minimum of

twelve months. The new, incremental subscription election capacity will be billed under Option 1 Subscription Charge Participant Program Year 1 in the first year, Participant Program Year 2 in the second year, and so on, and will be credited under the corresponding year.

If a customer elects to decrease customer's subscription, the subscribed capacity from the most recent subscription will be reduced first by the kW amount, which the customer has elected to decrease.

If a customer elects to discontinue service under Green Promise for one or more of customer's accounts, then the customer may not re-enroll that account or accounts in Green Promise for a period of at least one year after discontinuing service under Green Promise.

#### 64.5.2. Green Promise Option 2

The initial term of the Agreement under Green Promise shall be for a ten-year period and shall be extended automatically for successive periods of one year each until terminated by written notice given by one party to the other not more than six months nor less than two months prior to the expiration of the original term or any anniversary thereof.

When a customer elects a subscription amount, that subscription must remain in place for a ten-year period. After ten years, the customer may elect to decrease customer's subscription, or if subscription capacity is available subject to the waitlist, increase the customer's subscription. Any such change is subject to a modified Agreement, and the new election must remain in place for a new ten-year period. The new, incremental subscription election capacity will be billed under Option 2 Subscription Charge Participant Program Year 1 in the first year, Participant Program Year 2 in the second year, and so on, and will be credited under the corresponding year.

If a customer elects to decrease customer's subscription, the subscribed capacity from the most recent subscription will be reduced first by the kW amount, which the customer has elected to decrease.

If a customer elects to discontinue service under Green Promise during the initial ten-year term of the Agreement, then a termination payment will be required for each account that is discontinuing service under Green Promise. The Company will determine the termination payment by multiplying ten (10) percent times the remaining aggregate Option 2 Subscription Charge for the remainder of the initial ten-year term of the Agreement for the account(s) that are discontinuing service under Green Promise. If the customer can and does elect to assign the subscription to another existing account, the termination payment will not apply.
